and financing such projects with respect to their livelihood, earnings, business nature, unemployment to the local residents working here.

We claim that our rights and interests would be adversely affected due to Bank's violation of its policies and procedures on involuntary resettlment and project supervision. We further claim that our rights to participation and consultation were effectively denied and that our attempts to raise our concerns were not successful in particular, we claim that the failure to provide income restoration would result in significant harm. This failure would destroy our livelihoods, causing us to dismantle our productive sources and cause our supporting networks and kin groups to disperse.

4. Thus, the Bank's operational policies described in OP and BP 4.12 in the resettlement policy that "Displaced persons should be assisted in their efforts to improve their livelihood and standard of living or at least to restore them in real terms to pre-displacement levels or to levels prevailing prior to the beginning of project implementation whichever is higher" are totally neglected and violated.

We are unbale to understand that how and in what manner our standard of living and means of livelihood are going to be improved by entitling each of us for an area admeasuring 225 sq.ft each as rehabiliation compensation irrespective of the area consumed by the project, whereas the scheme provides for the actual area alone, the scheme provides "Every P.A.H. losing a commercial structure shall be eligible for an alternate place of commercial use of equivalent area" We fail to understand how this aspect of the scheme will be implemented when till date the actual area is not surveyed, no notice is received for survey by any of the shop owners, the actual area to be taken of the respective shops in the scheme is not ascertained then how the scheme will be implemented in its true spirit.

5. We have complained to the World Bank through several written letters (photocopies enclosed) to various authorities. We also had a meeting with the representative sent by your office, Mr. Sumir Lal, Advisor External Affairs on the 25th of March, 2004 at 3.30 pm at the MMRDA project office in Bandra-Kurla Complex in the presence of Mr. Shrivardhankar of MMRDA, Mr. Sumir Lal was kind enough to patiently listen to our problems, and directed Mr. Shrivandhankar to set up an information centre at the earliest in their office.
