## **EKSEKETIV SAMARI**

### ***Dispela Projek***

Long yia 2007, Wol Benk i tok oraitim IDA Invesmen Dinau moni mak olsem US\$27.5 milien wankain moni mak long PNG Kina bilong Indipenden Stet bilong Papua Niugini (PNG) Smolholda Agrikalsa Divelopmen Projek (SADP). As tingting em long strongim komyuniti wokbung insait long wok kamap na tu apim winmoni mak igo insait long lokol welpam prodaksen industri we istap pinis. Dispela wok bilong projek bai kamap insait long Oro na Wes Nu Briten provins namel long faef pela yia olgeta. SADP ikirapim bel wantaim bikpela sapot namel long ol welpam groas insait long ol projek eria.

Welpam industri bilong Papua Niugini i save givim bikpela halivim long ol rural wokman meri long kantri. Agrikalsa emi nambawan tru, olsem as bilong kamapim winmoni insait long ol hauslain long ples, na welpam isave givim ol smolholda gutpela karim long ol graun na tuhat, we i winim ol arapela kes krop olsem kakau na kopi. Welpam industri i kamap namba tu bihain long pablik sevis long mekim kamapim ol fomal wok bilong ol manmeri, mak inap olsem 23,000 ol i wok long welpam kampani. Wantaim dispela olsem 18,500 smolholda i save saplaim welpam prut igo long ol mil. Welpam i kamap olsem nambawan long apim agrikalsa foren eksens winmoni ikam insait long kantri makim 56 pesen long agrikalsa ekspot monimak insait long yia 2010.

Ol welpam kampani insait long Papua Niugini ol i go pas long wol long promotim sastenabol wok insait long sekta, na tu planti long dispela industri i kisim setifikeisen aninit long kivung bilong wanbel long Sastenabol Welpam; long tok inglis oil kolim Roundtable Sustainable Palm Oil (RSPO). Tingting bilong kamapim SADP em ibin lukluk long ol rot na wei, long mekim kamapim ol gutpela senis igo long ol man meri na haus laen insait long ol ples wantaim tu pasin bilong luksave long envairomen.

Igat tripela hap wok SADP i lukluk long em: (a) Namba wan em long halivim ol smolholda manmeri apim mak bilong prodaksen or karim bilong wel pam prut: pulumapim ol spes namel long ol blok, bilong ol ples arere long ol rot we istap pinis; mentenens wok long ol provinsel ekses rot na tu long kamap wantaim niupela wei long sapotim ol rot mentenens wok, na tu long strongim wok didiman igo long ol wel pam blok; (b) Namba tu em i lukluk long ol wok bung namel long lokol level gavaman wantaim komyuniti, we i sapotim ol lokol sevis wantaim infrastraksa (c) Namba tri i lukluk long menesmen bilong Projek wantaim sapot `igo long Oil Palm Industry Corporation (OPIC), husat bai go pas long ol wok bilong ol Projek; na long saet bilong skulim ol blok manmeri, wok painim aut o rises na tu ol arapela stadis tu.

Bod ibin tok oraitim dispela Projek long Mun Disemba yia 2007 tasol olgeta pepa bilong tok orait namel long Papua Niugini gavaman na Wol Benk ibin sainim long Mun Jenuari 2009. Ibin kisim longpela taim tru olsem wanelala yia mo long statim ol wok, long wanem ol gutpela saveman bilong menesmen long projek ino bin stat inap long yia 2010.

## ***Dispela Askim bilong wokim ol Wok Painimaut***

Wanpela NGO nem bilong em long tok inglis oli kolin Center for Environmental Law and Community Rights (CELCOR) ibin mekim dispela askim bilong wokim Wok Painimaut, makim maus bilong ol ples lain bilong Ahora/Kakandetta Presa Grup, ol arapela grup tu insait long Oro Provens wantaim ol arapela blok manmeri tu insait long tripela projek erias (Long hia oli kolin ol olsem “Rikuestas”). Oli mekim toktok olsem Projek bai inonap dainum pasin bilong sindaun turangu na tu halivim blok manmeri long apim o kamapim gutpela sindaun bilong ol. Oli sutim tok tu olsem, ino gat gutpela tok klia igo aut long ol ples o komyuniti, na ol bikpela toktok ino stap long tokples bilong ol yet. Ol i tokaut tu olsem ol rot we mentenens wok bai kamap, rot bai inonap stap gut long bihain taim tu. Bikpela toktok tu olsem pasin bilong skelim envairomen aninit long Projek ino bin luksave gut long ol asua Projek bai kamapim.

## ***Wok Painimaut Bilong Panel***

Panel i painim olsem sampela long ol toktok ino klia na tu pasin, na wei oli bin wokim ino stret. Ol toktok tu oli no bin tanim igo long tokples bilong ol manmeri. Wantaim dispela Panel ino bin klia tumas, komyuniti sapot bai kamap olsem wanem tru?
- ***Sindaun Turangu wantaim ol Hevi insait long Gutpela Sindaun.*** Panel i bin painim olsem Projek i bin bihainim Polosi bilong Benk long daunim pasin Turangu (Poverty Reduction – OP 1.00), tasol ino bin bihainim Polisi we bai luksave long ol asples manmeri (Indigenous Peoples Policy – OP 4.10), long pasin bilong strongim pasin na wei ekonomik wantaim sosol benefit bai kamap long Projek. Antap long dispela Projek ino bin lukluk gut long ol rot o pasin bilong lukautim na sevim winmoni, ol arapela rot bilong wokim moni tu. Long tingting bilong Panel Projek disain ino bin skelim na lukluk gut long ol Projek erias long wanem tupela provins ino wankain. Antap moa ino bin gat riviu long dispela institusanel wantaim fainansial vaiabiliti bilong ol welpam kampani.
- ***Ol Hevi Bilong Envairomen.*** Panel ibin painim olsem Projek ibin bihainim gut Polisi bilong Envairomen Asesmen (Environment Assessment – OP 4.01). Panel ibin painim tu olsem envairomen menesmen wantaim ol pasin bilong daunim hevi istap insait long skelim gut ol lukaut bilong Envairomen i bihainim gut tru OP 4.01. Dispela Panel i wanbel wantaim Menesmen olsem dispela Menesmen Eksen Plen bilong daunim ol hevi bilong Pipia Wara ikam long ol mil insait long wok

painim aut i wanel tru long daunim ol hevi. Panel i painim olsem Projek i bihainim Polisi OP/BP 4.04 we i lukluk long ol kainkain laip bilong graun wantaim bikpela tingting long bihainim Polisi OP/BP 4.36 we i luksave long ol diwai wantaim ol bus tu.

- **Institusanel Sastenabiliti.** Dispela Panel i kamap long ol tingting olsem sapos oli kamapim gutpela wei long wokim rot mentenens olgeta taim, dispela bai i halivim tru ol wel pam block manmeri na industri tu. Panel i painim olsem Menesmen ino bin lukluk gut long ol mentenens wok long ol rot na i larim tasol inap long taim bilong ol dispela wok i stat, na tu ino bin lukluk gut long hamas moni mak ol blok man meri bai putim insait olsem halivim bilong ol. Projek bai lukluk tu long strongim ol wok bilong OPIC long bihainim ol polisi. Panel I painim olsem OPIC i bihainim polisi long saet bilong lukautim gut ol wok OP 13.05 (Supervision).

*Menesmen i hamamas long ol wok painim aut bilong Panel we i karamapim ol polisi bilong Benk wantaim ol wei Projek imas bihainim*, dispela i makim na tok klia long OP 1.00 (Pasin bilong daunim sindaun turangu), OP 4.01 (Pasin bilong skelim Envaironment), OP 4.04 (Ol kainkain laip bilong dispela giraun), OP 4.36 (Ol diwai na bus) wantaim OP 13.05 (Wok lukaut long Projek). Menesmen i skelim tu las toktok bilong Panel we ol i tok Projek em i wanpela gutpela wei long daunim sindaun turangu wantaim nau lukluk tu long noken daunim na bagarapim ol bus wantaim ol ples we ol kainkain laip bilong graun istap. Menesmen i luksave tu long lukluk bilong Penel long ol sampela asua i kamap long taim bilong disainim Projek, na i laik mekim dispela toktok bekim igo long ol wok painim aut na stretim ol.

*Wol Benk i bin wok pinis insait long PNG long sapotim ol wok bilong wel pam mo long fopela-ten krismas nau, na dispela halivim i karim gutpela kaikai long mekim bikpela senis long lokol ekonomi na kamapim ol gutpela sindan.* Menesmen i bilip olsem dispela wok poroman wantaim Benk long sapotim wel pam insait long PNG bai halivim long daunim pasin bilong sindaun turangu, wantaim gutpela pasin bilong lukautim envaironment bilong nau na bihain taim tu.

*Menesmen i bilip olsem SADP em i wanpela rot bilong sapotim ol developmen insait long ol ples insait long PNG, na as tingting bilong em long kamapim ekonomi wantaim ol winmoni igo long ol man meri long ples, na tu long aburusim ol hevi bilong bagarapim bus na ol kainkain laip bilong graun.* Long lukluk bilong Menesmen dispela SADP, na lukluk bilong em long ol rot bai kamapim ol gutpela wok kamap long ol smolholdas wantaim komyuniti insait long Projek erias, insait na arasaet tu long wel pam sekta. Dispela SADP bai kamapim gutpela rot long ol sosol sevis wantaim maket bilong ol smolholdas wantaim komyunitis, na halivim ol long wok long ol arapela rot bilong painim moni tu we bai kamapim planti ol narapela wok kamap long daunim sindaun turangu.

*Menesmen i lukim tu olsem planti ol samting we ol Rikuestas i autim long ol wari bilong ol ino asua long ol wok kamap bilong SADP tasol. Menesmen i autim wari tu olsem Projek i kamap olsem rot bilong autim olgeta kainkain wari insait long wel pam sekta long PNG na long ol arapela kantri tu.* Olsem ol toktok insait long Panel Ripot “[..] planti ol bagarap we ol Rikuestas ibin autim pinis i bin asua long longpela

*taim pinis wantaim halivim bilong Wol Benk na tu taim ino bin gat halivim ikam long Wol Benk, olsem na ol Rikuestas i poret olsem ol dispela bagarap bai kamap bikpela moa long ol wok bilong SADP.” Menesmen i wanbel wantaim Panel olsem Projek ikamap wanpela rot bilong autim na kamapim ol pasin bilong daunim planti ol hevi wantaim bagarap ibin stap pinis bifo long Projek, we ino asua bilong SADP. **Menesmen i bilip olsem sutim tok long ol bagarap we ino bin gat wok kamap yet bilong SADP inap nao i soim olsem bai hat moa long luksave long ol hevi sapos i kamap long ol wok kamap bilong Projek we i kamap aninit long 1999 tok klia bilong Inspeksen Panel Resolusen.***

*Wanpela bikpela sutim tok Panel Ripot in kamapim, long inspeksen wok bilong SADP, em long aplikeisen bilong polisi bilong Benk makim ol asples man na meri o long tok inglis oli kolin long Indigenous Peoples Policy (OP 4.10). Long tingting bilong Menesmen, dispela Panel Ripot ibin autim planti toktok long aplikesen bilong OP 4.10, we Menesmen ipilim olsem bai imas mekim klia ol toktok long dispela Ripot.*

*Menesmen i bilip olsem bikpela samting tru long luksave olsem dispela Benk polisi makim ol asples man meri i kamap bihainim bikpela toktok igo ikam namel long ol Asples man meri wantaim Bod. Menesmen igat bikpela komitmen long aplaim dispela polisi long wei na pasin Bod i wanbel long em. Menesmen iluksave olsem ol lo aninit long OP 4.10 – makim sosol asesmen, konsalteisen proses o pasin bilong toktok igo ikam, wantaim plen bilong ol Asples man meri o Indijines Pipols Plen – dispela polisi i tok olsem “*dispela mak bilong toktok bai bihainim [...] ol kainkain wok bilong projek na makim tu skel bilong ol hevi projek bai kamapim long ol Asples man meri sapos i kamapim ol gutpela samting o nogat*”. Menesmen i bilip olsem long strongim luksave bilong OP 4.10 long kamapim ol wok glasim we i wankain long ol skel bilong ol hevi projek ikamapim, makim dispela ol toktok insait long ol pepa o dokumen i wanpela bikpela samting long Indijinas Pipols Polisi, we bai soim trupela wok bilong Benk na projek developmen bai imas lukautim na bihainim gut.*

*Long tingting bilong Menesmen, dispela wok glasim long SADP ibin luksave long ol skel mak bilong ol hevi projek bai kamapim, na tu em bai stap stret long sambai wantaim ol rot na pasin bilong daunim ol hevi we i stret wantaim benefit tingting bilong ol ples lain. Dispela Projek ibin givim wok long tupela save man meri husat oli gat bikpela wok expiriens insait long Papua Niugini na wel pam sekta. Menesmen i bilip olsem ol mak bilong ol toktok makim ol ligel na institusenel fremwok bilong ol kastam lo, makim lidasip, pasin bilong kamapim gutpela tingting na stretim ol hevi, wantaim ol beslain data we i stap insait long ol Projek pepa emi stret tru wantaim projek, na ibihainim wanem samting ibin kamap pinis bipo long PNG na ol arapela hap tu, na dispela i soim na luksave long wanem samting projek bai wokim long go het yet long ol wok. **Wankain tu, Menesmen i bilip olsem ol wok glasim i bihainim ol tingting bilong dispel polisi OP 4.10.***

*Bihainim dispela wok painimaut bilong Panel, long saet bilong ol toktok igo ikam o kivung, nau i wok long go het yet bihainim ol wok kamap aninit long Projek na tu oli rekodim. Namel long yia igo pinis, moa long tupela-ten kivung ibin kamap long ol fil dei, na moa long sevenpela-ten faiv kivung ibin kamap long ol tok orait bilong ol komyuniti makim ol rot mentenens. Samting olsem eitpela-ten kivung oli bin olim bihainim ol askim bilong ol ples man meri long toktok long ol arapela samting tu.*

*Menesmen i givim bikpela luksave long ol wari kamap insait long dispela Rikues bilong wokim Inspeksen wantaim tu ol samting Menesmen ibin luksave pinis na wok long go het long stretim.* Insait long ol implimentesen sapot bilong SADP, Menesmen i wok long go het yet wantaim ol sapot igo long OPIC long strongim ol kivung na toktok igo ikam, bikpela hap tru em long rekodim gut ol dispela toktok. SADP's grievance redress mechanism has been strengthened. Menesmen tu i givim bikpela halivim long sapotim implimentensen na tu long halivim OPIC long strongim kapasiti o save long bihainim gut ol pasin bilong luksave na daunim hevi.

### **Eksen Plen**

*Menesmen i luksave na wanbel long Panel long ol lukluk glasim bilong ol, long ol saet bilong bihainim pasin bilong wokim gut wok na dispela i stap pinis long ol bekim ikamap long yia 2010, we ol wok bilong stretim ol dispel hevi i kamap pinis.*

Long bekim bilong Menesmen igo long Panel Ripot, Menesmen i komitim em yet long go het wantaim Projek implimentensen na wokim ol dispela eksens:

- Menesmen bai halivim OPIC long kamap wantaim Konsaltesen Fremwok na bai strongim dispela tingting long implimentim long olgeta tripela Projek erias;
- Menesmen bai halivim na sapotim OPIC long kamapim gutpela moa pasin bilong rekodim ol kivung o ol tok tok namel long ol ples lain long taim bilong implimentesen;
- Menesmen bai go het yet long sapotim na tu monitarim ol implimentensen long ol Eksen Plen bilong ol Pipia wara I kam long ol wel palm mil o Efluen; wantaim tu
- Menesmen bai lukluk gut moa long ol konsaltesen wok na rekodim long saet bilong Rot Mentenens Tras Fan (RMTF) stadi we bai mekem kamapim mak bilong ol levi, sapos bai gat, tasol bai lukluk gut long noken kamapim moa hevi long ol win moni mak bilong ol smolholdas.

### **Sampela ol arapela Hevi**

*Menesmen i luksave long Panel Ripot, long sapta 7 long ol arapela hevi we ino toktok long ol pasin bilong bihainim wok, o kamapim ol bagarap we i kamap aninit long ol wok bilong SADP, tasol we i lukluk long pasin bilong skelim na sekim o riviuim SADP.* Menesmen i luksave olsem Panel Ripot i toktok long ol arapela samting we inobin lukluk long ol hevi we i kamap aninit long SADP, tasol 1999 Klarifikasi bilong Resolusen i tok olsem “*Dispela Panel bai skelim tingting insait long ripot tasol long ol bikpela hevi, ol sut tok insait long rikues, we ikamap long asua bilong Benk long taim we ino bihainim ol polisi na presidia bilong em.*”

Dispela Panel Ripot i tok tu olsem Sosol Asesmen i painim mak bilong ol hevi na tu ol gutpela bilong SADP bihainim OP 4.10, tasol sukuruim olsem dispela painim “*iluk olsem* ino bin wokim gut.” Menesmen i no bin klia long ol kain kualifikesen long bihainim Polisi olsem na i painim hat long bekim, long wanem I lukim olsem dispela i bihainim Benk Polisi olsem Panel i tok pinis.

Dispela Panel Ripot i laikim tu bai imas gat klia to o gaidlain bilong Benk OP 4.10 we imas mekim kamapim bilong ol projek we Indijinas Pipols Plen em yet inonap sanap. Menesmen ino lukim nid bilong dispela gaidlain, long wanem i ting olsem ol dispela polisi we istap pinis bai stretim ol dispela samting ikamap.

Dispela Panel Ripot i lukluk long *Wol Benk Grup Fremwok wantaim IFC Strateji bilong Wok bung insait long Wel Pam Sekta* na tingting long sapotim wok bihainim dispela Fremwok bihainim investigesen long SADP. Menesmen i pilim olsem sampela toktok moa long Fremwok, we Bod i tok oraitim pinis emi i sanap makim pasin bilong bihainim riviu long SADP.

## **I. TOK I GO PAS**

1. Long mun Disemba 17, 2009, Inspeksen Panel i rejisterim wapelala Rikues bilong wokim Inspeksen o wok painim aut, IPN Rikues RQ 09/10 (insait long hia oli kolin olsem “dispela Rikues”), makim Papua Niugini (PNG) Smolholda Agrikalsa Developmen Projek (“SADP” or “dispela Projek”) Intanesenel Developmen Asosieisen (IDA). Dispela askim long wokim wok painimaut ikamap long singaut bilong Ahora/Kakandetta Presa Grup, ol papa graun bilong Oro Provins wantaim ol arapela welpam blok manmeri insait long wapelala long tripela projek erias (the “Requesters”). Ol laen i wokim dispela singaut i askim tu olsem nem bilong ol bai noken kamap ples klia na bai NGO grup oli kolin long Senta bilong Envaironment Lo na Komyuniti Raits (CELCOR), bilong Papua Niugini bai makim maus bilong ol dispela laen.
2. Ol Eksekutiv Darektas wantaim Presiden bilong IDA i bin kisim toksave long Panel olsem oli kisim dispela Rikues. Menesmen i bin bekim ol dispela sutim tok istap insait long dispel Rikues long mun Februari namba 8 dei, long yia 2010.

Long tingting bilong Menesmen SADP, bai lukluk long ol rot na o wei long kamapim ol gutpela benefits igo long ol smolholdas insait long Projek erias, long insait na tu long arasaet long wel pam sekta.*

18. *Wol Benk i stap pinis long wel pam sekta insait long PNG moa long fopela-ten krismas, stat wantaim ekonomik stadi long yia 1965 bihain faef-pela invesmen stat long yia 1968 ikam inap nau.<sup>3</sup>* Wol Benk invesmen insait long wel pam sekta long PNG ibin gat pinis ol gutpela samting ikamap long lokol ekonomi na tu ol rurel sindaun insait long ol Nucleus Estate Scheme long PNG. Menesmen i bilip olsem wok bilong Benk insait long wel pam sekta bai kamapim gutpela sindaun na daunim hevi bilong sindaun turangu na tu long pasin bilong lukautim envairomen long pasin bilong sastenebel wei.<sup>4</sup>

19. *Taim Benk I bin kam bek gen long PNG long yia 2005, oli painim olsem wel pam emi gutpela rot bilong kirapim wanpela invesmen projek na kamapim gutpela sindaun long ol rurel erias.* Tasol long tingting long ol hevi bilong envairomen we isave kamap long ol wok developmen, Benk ibin sotim ol sapot igo long ol smolholdas we oli stap pinis long ol wel pam skim, na lukluk moa long apim winmoni mak long saet bilong apim prodaksen na stretim ol rot insaet long ol dispela skim.

20. *Wel Pam Indastri bilong PNG i putim hanmak long apim winmoni igo long ol rurel erias long kantri.* Wel pam isave givim gutpela prais tru igo long ol smolholdas na bekim gut tuhat bilong ol sapos yumi skelim wantaim kakao na kopi. Dispela indastri emi kamap namba tu bihain long publik sevis long saet bilong givim ol wok, wantaim 23,000 man meri i wok insait long ol wel pam kampani. Samting olsem 18,500 smolholdas I save saplaim ol mil wantaim ol wel pam prut.
