FEATURE

POWER DEVELOPMENT (NEPAL) - Board Meets to Discuss Panel Report



The Panel received a Complaint in July 2013 concerning the Power Development Project (PDP) in Nepal which is addressing the country's chronic energy shortages. The Request was submitted by 103 indigenous and non-indigenous families from three villages of the Sindhuli District. The Request raised instances of harm or potential harm related to displacement, compensation, cultural and health issues due to the construction of a high voltage transmission line in their community. The Complainants also stated that they were not adequately informed and consulted on the design and location of the transmission line. The Panel submitted its Investigation Report to the Board of Executive Directors in February 2015, and Manage-

ment's Report and Recommendation was sent to the Board on March 2015. The Board, which met on July 13, 2015 to discuss the Panel report, thanked the Panel for its "rigorous assessment" of the problems raised by the community, and approved the Management Action Plan which focuses on "amicably resolving" the outstanding issues. ACTIVE CASES

ELECTRICITY EXPANSION (KENYA) - Panel Completes Investigation Report

Several *Maasai* communities in the Rift Valley Area in Kenya submitted a Complaint to the Panel in October 2014 raising concerns about resettlement (compensation and livelihood restoration), consultations, cultural heritage and their identification as Indigenous Peoples as a result of a recently installed geothermal power plant. The Panel and the Complaints Mechanism of the European Investment Bank (EIB) conducted a joint investigation visit to Kenya in March 2015 to assess the situation. After meeting with a wide range of stakeholders in Kenya and conferring with resettlement experts,



the Panel submitted its Investigation Report to the Board of Executive Directors on July 02, 2015. The Board is expected to meet and discuss both the Panel and Management's Recommendation Reports in the next few months. *More*

MINING INFRASTRUCTURE (MONGOLIA) - Panel Completed Site Visit



The Panel registered, on February 10, 2015, a Complaint received from several local Mongolian and Russian community groups concerning the Mining Infrastructure Investment Support Project (MINIS) which is an IDA credit of US\$25m geared to install energy infrastructure to support mining operations. The Complainants state that if the feasibility studies of the *Shuren* Dam and the *Orkhon Gobi* Water Diversion projects go forward, they could have severe impacts on communities in Mongolia and on Russia's Lake Baikal, which is a World Heritage Site. A Panel Team visited the pro-

ject site areas in Mongolia and Russia in May 2015 and met with a wide range of stakeholders. The Panel submitted to the Board its Report and Recommendation on July 02, 2015. <u>More.</u>

RECENT COMPLAINTS

ENERGY SECTOR (KOSOVO) - Panel Will Visit Site Soon

The Panel received a Complaint from residents of *Hade* and *Obiliq* municipalities in Kosovo on June 12, 2015. The Complaint concerns three Bank-financed operations involving resettlement, land reclamation, and regulatory framework undertaken in preparation for the Kosovo Power Project which the Bank is considering financing. The Complaint identifies several harms related to loss of land, reduced livelihoods, restrictions on economic development, and displacement due to the expansion of a coal mine. The Panel registered the Request on June 30, 2015, and will undertake a site visit in August to assess if the Request meets the Panel's eligibility criteria and if the harms merit an investigation. *More*

BLOGS OUTREACH

Impressions from a Visit to Hells Gate



Jan Mattsson, a Member of Panel, shares his impressions from a fact finding trip he took in March 2015 to the Hell's Gate National Park area in Kenya. This was part of a joint investigation visit undertaken with the European Investment Bank's compliance unit, to assess the

complaints made by four *Maasai* indigenous communities about problems related to resettlement and loss of livelihood due to the installation of geothermal plants on their ancestral lands. Jan spent nearly a week visiting local sites and meeting with villagers, government officials, local Bank staff, and other stakeholders. This was his first investigation with the Panel and it served to confirm that the truism that 'every case is unique, and that every case is complex" is indeed true. He also reflected on the pros and cons of undertaking a joint investigation with a sister agency. *More*

Spring Meetings Sessions

The Panel hosted two large policy dialogue sessions during the WBG/IMF Spring Meetings on April 16 – 17, 2015. The first, titled "Accountability for Better Development Outcomes: A Conversation with Government, Industry and Civil Society" was jointly sponsored with the CAO. <u>More</u>. The Panel organized a CSO Outreach Workshop with other Independent Accountability Mechanisms (IAMs) in Istanbul, Turkey on May 12 – 13, 2015. Over 30 CSO Representatives from Turkey and 10 other countries from the

The purpose of the two-day event was geared to sharing information about the compliance work of the IAMs; listening to CSO experiences in engaging these mechanisms; and exchanging views and ideas on how to strengthen accountability principles and practices in the ECA region. <u>More</u>

Conscience International (CI) and the Panel organized a CSO outreach meeting in Banjul, Gambia on 19 April 2015 for CSO delegates attending the 56th Ordinary Session of the African Commission on Human and People's
