Ol luksave long dispela projek long 2003 bihain long Wol Benk i givim halivim moni long Oro Smallholder Oil Palm Development Project. Tasol, i bin hevi wantaim Wol Benk na gavman bilong PNG long ol i no bihainim sampela gutpela pasin long lukautim graun na bus, ol pasim SADP i go i nap long 2005. Ol wok bung wantaim na lukluk gen long projek i no kamap inap long 2006 na wok i redi long 2007. Insait long dispela taim, planti senis i bin kamap we ol traim long planim gen sampela hap we oil pam kamap lapun na ol i mas planim nupela pam oil. Tasol dispela senis na ol planim oil pam arere long rot na stretim ol rot. As tingting em long

kirapim tingting long mekim oil pam kamap bikpela bisnis long pulim moni insait long we projek stap long en.

Wol Benk wantaim sponsa bilong projek i no sindaun wantaim ol lain askim wantaim ol arapela lain insait long komuniti. Projek i gat tripela komponen o hap. Komponen 1 luksave long infilling o planim oil pam arere long rot na stretim rot, Komponen 2 luksave long sindaun bilong pipol insait long LLG, Komponen 3 tok long sapot i go long ol husat mekim long OPIC.

- a). Komponen 1: Planim oil pam arere long rot, stretim rot, kisim takis long rot na trening bilong OPIC.

Komponen 1 i gat ol arapela liklik hap komponen wantaim pasin long kisim dinau, wokim nupela rot, stretim rot, moni bilong stretim rot, na trening bilong OPIC.

Tok long Dinau, ol save givim dinau long ol blok lain laik planim oil pam. Pastaim ol husat kisim dinau i mas stap insait long blok we i stap klostu long rot we nogat oil pam stap long en. Ol lain Askim i ting olsem long planim oil pam arere long rot mekim projek kamap bikpela na yusim kain tok olsem “infilling” traim long giamanim na trikim ol. Bai Benk givim dinau moni long planim oil pam arere long rot oil pam stap long na traim long planim oil pam tasol bai ol mekim oil pam projek kamap bikpela sapos ol planim oil pam arere long rot we bikpela bus stap long en. Dispela ol bus arere long rot i no liklik hap, ol man save kisim halivim long en we ol wokim gaden. Ol bai kisim K3 long wanwan tonne long oil pam na moni ol kisim bai i go insait long lukautim ol rot long Bialla na Hoskin. Na K6 long Oro. Bikpela moni bai i kam long PNG Sustainable Development. Wol Benk tok olsem dispela plen i stap long tingting yet na i no mekim yet. Tasol tingting long mekim tru wok i stap long wok mak insait long RMTF na stap ples klia long projek pepa. Ol nogat plen long lukluk gen long stretim rot o ol arapela we long lukautim ol rot stap insait long plen bilong ol. RMTF bai kamapim bikpela hap long dispela projek.

Laspela hap Komponen long givim halivim long moni na ol teknikal wokman bilong OPIC. Tasol, ol i no save wanem kain treining ol bai kisim. Ol bai kisim moa wokman long OPIC na moni i kam long ol blok lain wantaim miling kompani bai baim ol.

*b) Komponen 2: Projek long Sindaun long ples long LLG.*

Komponen 2 tok long bringim developmen long lukautim sindaun bilong ol komuniti grup insait long SADP hap o blok. Nambawan hap long dispela wok bai ol mekim insait long tupela yia na wok insait long faivpela LLG. Narapela fopela liklik projek bai ol givim moni long olgeta LLG kamap olsem K80,000 long wanwan LLG. Narapela faivpela liklik projek bai kirap long yia namba 2 na narapela 6 pela projek long yia bihain. Narapela kompani bai lukautim Komponen 2 na OPIC bai givim kontrak long em. Bihain long tupela yia, ol bai skelim wok long mekim namba 2 hap we projek kirap long narapela 15 pela LLG insait long tripela distrik long projek.

*c) Komponen 3: Sapotim OPIC*

Komponen 3 tok long givim teknikal halivim long OPIC na kamapim wanpela we long was na skelim projek. Insait long dispel hap bai ol lukluk long Fresh Fruit Bunch na we ol makim prais long en. Projek bai strongim na mekim gut na halivim ol long givim long wok painimaut. ## **Hap B Hevi bilong Projek**

### **B.1. Ol Bikpela Senis Long Oil Pam**

Pastaim long planim oil pam, ol mas rausim olgeta bus na gras. Dispela i gat planti hevi we ren wara i ken rausim graun, graun bruk kwik taim na graun bruk i go na bagarapim wara. Insait long

PNG, ol loging kompani daunim planti diwai na graun slip nating na ol ting graun i bagarap olgeta olsem i no gutpela tumas. Nau ol planim oil pam. Olsem na ol man i mas luksave olsem bus em bikpela samting long sindaun bilong man long ples. Sapos nogat bus, ol i gat narapela kain tingting long graun we ol ting graun bagarap olgeta. Ol man long ples, kisim kainkain halivim long bus long lukautim sindaun bilong ol. Na tu bus i gat kainkain binatang wantaim abus. Ol mekim wok painim aut na ol lukim olsem oil pam plantesin bai lukautim 20% tasol long ol abus, snek na Pisin.

Namba 2 samting, oil pam bisnis mekim na kapsaitim ol marasin nogut na bagarapim ol wara. Long planti plantesin na blok, ol yusim planti marasin long lukautim graun na sampela diwai. Sapos ol i no yusim ol marasim bilong wok didiman gut, ren i ken karim marasin i go long ol wara na bagarapim ol na olgeta binatang stap insait long en. Tu, ol pipia mikis long Miling kompani i ken go bagarapim wara. Pipia mikis long ol Miling Kompani i gat sampela samting ol saveman luksave ol bagarapim ol wara na raun wara.

Ol lain long ples toksave olsem pis long ol raun wara na wara wok long go daun na ol ples bilong waswas bipo klin tasol taim ol bringim oil pam bisnis kala bilong wara wok long senis na i smel nogut tru. Ol meri toksave olsem ol wok long lusim planti piknini long bel, sampela bebi nogat han, leg o sampela hevi wok long kisim ol bebi bihain long ol bringim oil pam bisnis i bin kamap long ples (Walker, E. 2004).

Namba 3, oil pam i no bringim planti senis i kam long laip bilong man long ples. Ol kainkain halivim ol save kisim long we ol save sindaun long ples long kisim kaikai, insait long papa graun i winim liklik moni ol kisim long oil pam na lukautim ol yet. Long sampela ples, ol salim kaikai long ples na pulim moa moni sapos yu skelim wantaim ol moni ol blok lain same kisim long oil pam bilong ol (Anderson 2008). Oil pam yusim planti graun na i no inap long yusim hap graun long planim ol arapela samting long pulim moni olsem kopi, cocoa na vanilla. Oil pam bisnis i no inap givim spes olsem na sapos prais bilong oil pam i go daun oil pam i no karim gut ol lain lukautim oil pam i no kisim planti halivim.

## **B.2. Oil Pam i no halivim planti long sindaun gut**

Ol arasait investa, olsem Wol Benk na Asian Benk i bin stap insait long Oil Pam bisnis na winim 50 yia olgeta. Nambawan taim long planim oil pam long 1966, ananit long Wol Benk long Hoskins West New Britain. Oil pam wok long kamap bikpela we bikpela oil pam plantesin wantaim ol viles oil pam na blok long graun bilong gavman kamap 46,000 hektea tasol nau winim i go antap long 73,000 hektea namel long 1990 na 2003. Wanpela long dispela projek Wol Bonk wok long halivim em Oro Samholder Oil Palm Development Project long 1993 na dispela mekim na Wol Benk putim \$100 milion i go long Oil Pam bisnis.

Ol putim planti moni i bin i go insait long Oil pam tasol i nogat bikpela halivim i go long ol blok lain long lukautim ol yet. Sindaun bilong ol lain bagarap na kaim mak bilong dispela yu ken lukim long kain haus ol slip long en, wara ol dring, na sevis long helt i no gutpela tumas (Social Assessment Report, January 2007, page 46). Liklik wok Wol Benk mekim long tingting bilong ol lain sindaun long projek, planti ol sindaun long bus haus ol wokim wantaim diwai, kunai lip wantaim bambu we dispela wok long soim olsem nogat wanpela gutpeal development i go long ol. Tu ol skelim sindaun bilong ol lain wok ananit long SADP soim olsem ol kisim bikpela moni na winim ol lain kisim long kopi na cocoa tasol ol i no lukim planti senis i kam long sindaun bilong ol.

### **B.3. We SADP stap nau i no inap halivim gutpela sindaun na pasin sampela arapela developmen**

Ananit long SADP, ol blok lain bai nogat planti we long mekim gut gutpela sindaun bilong ol. Namwan samting ol wokman kamap lukluk tasol long ol miling kompani we ol salim oil pam i go long ol tasol na ol i no i nap salim oil pam long narapela lain. Ol blok lain tu putim moni long lukautim ol rot kain olsem na wok long mekim moni ol kisim kamap liklik. Antap long en, fama wok long baim wokman, marasin, na ol masin wantaim sid.

We ol putim prais long FFB soim tru piksa bilong ol tok stap antap we i lukim ol fama i pein olgeta samting. FFB prais ol lain Palm Oil Producers Association (POPA) we ol dispela lain bilong Miling kompani. Tasol tok ol wok long mekim i no stret na i no bihainim lo olsem na ol bihainim sampela tasol. Ol wok painimaut long senisim sampela samting sapos hevi stap wok long halivim ol kompani na i no halivim ol blok lain o smallholders na ol wok painimaut i no kisim tingting bilong ol smallholders. Olsem na prais ol putim wok long sapotim ol kompani we ol wok long daunim kost na pe bilong graun. Ol lukluk planti long pe na masin bilong ol miliong kompani. Ol SADP wok long yusim prais ol bikpela kompani bilong arapela kantri wok long putim na lukautim na bosim bisnis gut.

Namba 2, antap long skelim moni, ol smallholders bai baim planti takis moni long lukautim oil pam. Bihain long kompani rausim dinau moni long taim ol kamautim oil pam (30%) ol smallholders baim 44% long takis long gavman we ol i no kisim sevis bilong ol. Na tu ol baim fi bilong kamap memba long Growers Association na fi bilong trak long karim oil pam i go long mil.

Moa yet, ananit long SADP, ol bai sasim smallholders long sapotim wok long stretim ol rot (RMTF). Dispela fi bilong lukautim rot kamap namel long K3.50 na K6 long wanwan tonne long FFB long taim bilong kamautim oil pam. Ananit long buk bilong SADP lukluk na skelim, dispela fi bai karamapim olgeta smol holda na bai putim moni i go long RMTF. Dispela mekim ol smol holda wokman bilong ol miling kompani na bai wok long givim hevi long ol smol holda ba bagarapim sindaun bilong ol.

Oil pam i pasim arapela we long lukautim ol yet. Ol wok long mekim oil pam kamap bikpela na em tasol wok long pulim moni i kam long ol lain asples long ol tripela hap stap long en. Dispela pasin we wanpela we tasol long kisim moni i no bihainim tingting bilong Wol Benk we Wol Benk laik lukim ol asples lain i mas mekim narapela kain wok long bringim moni i kam long wanwan femili long blok insait long we projek stap long en. Taim SADP skelim sindaun bilong ol pipol mekim kainkain we long kisim moni en wanpela bikpela samting long bringin senis i kam long komuniti. Oil pam kamap bikpela bisnis long ples long Oro na West New Britain provins. Planti ol smol holda laikim arapela we long halivim ol stap gut long ples. Olsem tok stap antap, oil pam karapim olgeta graun na hat long planim narapela samting long pulim moni. Projek traim long bringim ol liklik bisnis na trenim long mekim wok olsem ol wokman long wok long fam insait long Komponen 1. Tasol ol i no halivim ol lain long mekim narapela kain wok.

Ol lain raitim pas wanbel olsem ol lain lukautim oil pam tasol i no i nap sapotim ol yet long moni ol kisim long oil pam na ol laik mekim narapela samting long lukautim ol yet.

#### **B.4. Nogat wanpela toksave or toktok wantaim bipo long ol tok orait long projek olsem na ol mekim asua pinis long projek.**

Wanpela bikpela hevi ol raitim pas tokaut olsem OPIC i no bungim ol na toksave bipo long ol tok orait long projek i ken go het na tu Wol Benk i no toksave long olgeta tripela hap SADP stap long en. Ol komuniti Raitim dispela pas i no harim toksave tu na i no klia long ol dispela projek.

*Bikpela samting ol lain Raitim dispela pas tok olsem ol i no toksave long ol arapela rot takis ol putim taim ol putim nupela oil pam. Sapos ol i bin toksave pastaim, ol inap long tokim ol arepela we long kisim moni na bai inap long toktok long nupela takis ol putting long rot.*

Wol Benk em raitim pas i go long CELCOR na tok olsem ol i bin sindaun toktok bipo long 2007 wantaim ol sios, ol NGOs na ol lain long ples, yut na asosiesen bilong ol fama. Tasol ol nogat wanpela ripot stap long luksave long dispela bung i bin kamap. Bai gat olsem 4,370 ol nupela growa antap long 15,000 stap pinis insait long tripela hap SADP stap long en na nupela fi ol putim bilong stretim rot na tu nogat ripot stap long soim olsem kain tok i bin kamap wantaim ol gru antap. Olsem ol askim sapos Wol Benk i bin bihainim stretpela rot long mekim wok na kisim sapot bilong pipol.

Ol lain Raitim pas tok olsem ol i no bung planti taim na toktok wantaim ol pipol na ol i no toktok long projek olsem na kain pasin i no halivim ol long mekim disisen gut.

Tu, ol i no givim ol wok buk bilong projek i go long ol smallholders or putim long ples ol i nap long kisim. Long dispela taim nogat wanpela wok buk bilong projek long ples projek stap long en we ol mekim wanpela toksave long National Niuspepa long 22 Febuari 2007 olsem wok buk stap pinis long we OPIC opis stap long en. Taim ol toktok wantaim ol OPIC projek Meneja, ol i no klia we stap ol wok buk. Antap long en, ol wok pepa ol tilim long taim bilong opim projek long mun Mas 2009 ol putim long CD rom bihain tru long tok orait long projek.

Bikpela samting olsem tok ol raitim stap long inglis na i no narapela tokples. PNG i gat planti tokples stap, na tok pisin em bikpela tokples long PNG planti pipol save na plnti long ples projek save long tok Pisin. Nogat wanpela wok buk ol tanim i go long tok pisin na putim o rikotim long teip bipo long ol tok orait long projek.

#### **B.5. SADP projek no inap stap longpela taim**

Ol raitim pas ol wari long tupela bikpela samting long projek, wanpela en moni bilong stretim ol rot na wokman bilong OPIC save wok long fam. Projek stanap antap long dispela tupela samting tasol we ol stretim i no gutpela tumas na ol i no i nap stretim gen taim projek pinis.

a) Mak bilong Lukautim Moni long Stretim rot.

Wanpela mak bilong SADP projek em bilong halivim ol smallholder stap strong insait long PNG(PID page12). Wanpela long halivim ol long sanap strong sapos ol stretim ol rot gut long karim ol oil pam igoi go long ol mil.

Long dispela taim, rot insait long ol tripela SADP hap ples i bagarap olgeta na ol smal holda lain kisim bikpela hevi we ol trak i no i nap kisim oil pam bilong ol i go long mil. Ol rot bagarap na ol helt sevis wantaim skul insait long smallholder bagarap olgeta. Na tu ol putim pe long ol trak long karim oil pam. Dispela pe em bilong lukautim trak na bikos rot i no gupela olsem em kostim planti moni long stretim ol trak.

Bipo ol developmen projek insait long oil pam stap long en ol inap long putim gutpela rot long lukautim ol oil pam mil. Long Oro Wol Benk smallholder Oil Palm Development Project long 2001 i nap long mekim 80 kilomita nupela han rot na 392 long kamautim oil pam. Nogat gutpela wokman long bosim ol kontrakta, ol kontrakta nogat planti save long mekim rot, nogat gutpela baret, na ol sot tru long wokim rot gut. Olsem na ol i no wokim rot gut na lusim 180 kilomita rot ol i no wokim. Dispela kain hevi em stap long ol tripela projek stap long en.

Wol Benk tok olsem ananit long SADP, ol husat yusim rot i mas baim we smol holda putim moni wokim rot i go long stretim rot ananit long Road Maintenance Trust Fund (RMTF) long mekim ol han rot stap longpela taim.
